ORDER (COMPELLING SCHOOL ATTENDANCE)

THIS MATTER came on for hearing this date upon the Petition of the Board of Education of Moffat County School District RE:1, through its duly appointed attendance officer, Bill Toovey. The Respondent(s) _____ **(appeared)(did not appear)**, and the Minor Child above-named **(did)(did not)** appear. The Court, after hearing the statements of counsel and the Respondent(s) herein, having examined the file, and having heard the testimony of the witnesses presented, makes the following

FINDINGS AND CONCLUSIONS:

1. The Petition herein, together with a Summons and the required Statutory Notice, were all duly served upon the above-named Respondent(s) and Minor Child. Inasmuch as the Minor Child is under the age of sixteen (16) years old, the Court finds and concludes that it has full jurisdiction over the subject matter and over the parties.
2. The Court finds that the said Minor Child is under the age of sixteen (16) years old, resides within Moffat county School District RE:1, that the said Minor Child has failed to attend school as required by the "School Attendance Law of 1963", C.R.S. §22-33-101, *et seq.*, and that no just cause for such failure appears.

WHEREFORE, IT IS HEREBY ORDERED:

A. That the Respondent(s) herein exercise such parental control over the above-named Minor child as is necessary to insure said Child's attendance at school without any further unexcused absences; and

B. That the Minor Child attend school without any further unexcused absences; and

C. That if the Respondent(s) herein refuse(s) or neglect(s) to obey this Order, the

Court may upon a proper showing require the said Respondent(s) to show cause why a Contempt Citation should not issue; and

D. That if the Minor Child herein refuses or neglects to obey this Order, the Court may upon a proper showing require the said Minor child to show cause why a Contempt citation should not issue; and
